Thank you for helping us prepare Rwanda's most talented and dedicated students for extraordinary lives as influential entrepreneurs and hard-working servant leaders. When inspired by God's call to love and serve, they are the world's most sustainable solution to poverty, disease and corruption. They are the hope of Africa.

Already you have blessed me, Bishop John and Bridge2Rwanda with your encouragement and prayers. By God's provision, we have witnessed gifted individuals and organizations join together to establish Sunrise School, Urwego Opportunity Bank and the Rwanda Presidential Scholars Program – institutions transforming Rwanda.

Now, I am asking you to make a tax-deductible contribution to Bridge2Rwanda before the end of 2009. We need to raise \$790,250 this year. Here's why.

Our goal is to launch Muhabura ("the True Guide") University and make it one of the premier universities in Africa for servant leadership, entrepreneurship, business and engineering. The 25-acre site was donated by the Government of Rwanda and will ultimately be home to 2,000 students. Yet before the end of this year, we need to raise money to:

- Renovate 12 existing buildings into classrooms, dormitories, offices and a dining hall to accommodate up to 250 boarding students. We'll also install a wireless network to cover the entire campus.
- We've hired Glen Woodruff, Muhabura's president, but we now need to hire faculty and mobilize volunteers to develop the school's initial programs.
- At President Paul Kagame's request, Muhabura will establish a program to improve the English proficiency of the nation's top students. This year, we will offer an intensive 3-month English language program for up to 100 Rwandan Presidential Scholars entering U.S. universities next Fall.

These initiatives will transform lives and create educational opportunities for some of the most promising young people of Rwanda – talented students who are committed to being job creators, rather than job seekers.

Hugh, I am grateful for your friendship and support. God's divine hand has drawn you to His miraculous work in Rwanda and I want to encourage you to invest in these remarkable students -- to put your treasure where your heart is -- to prepare them to lead, to serve and to transform their nation and Africa.

I know times are challenging for many people in America. But compared to Rwanda, our undeniable abundance dares us to create more and better opportunities for these deserving students. Future leaders you will be proud to know and support.


