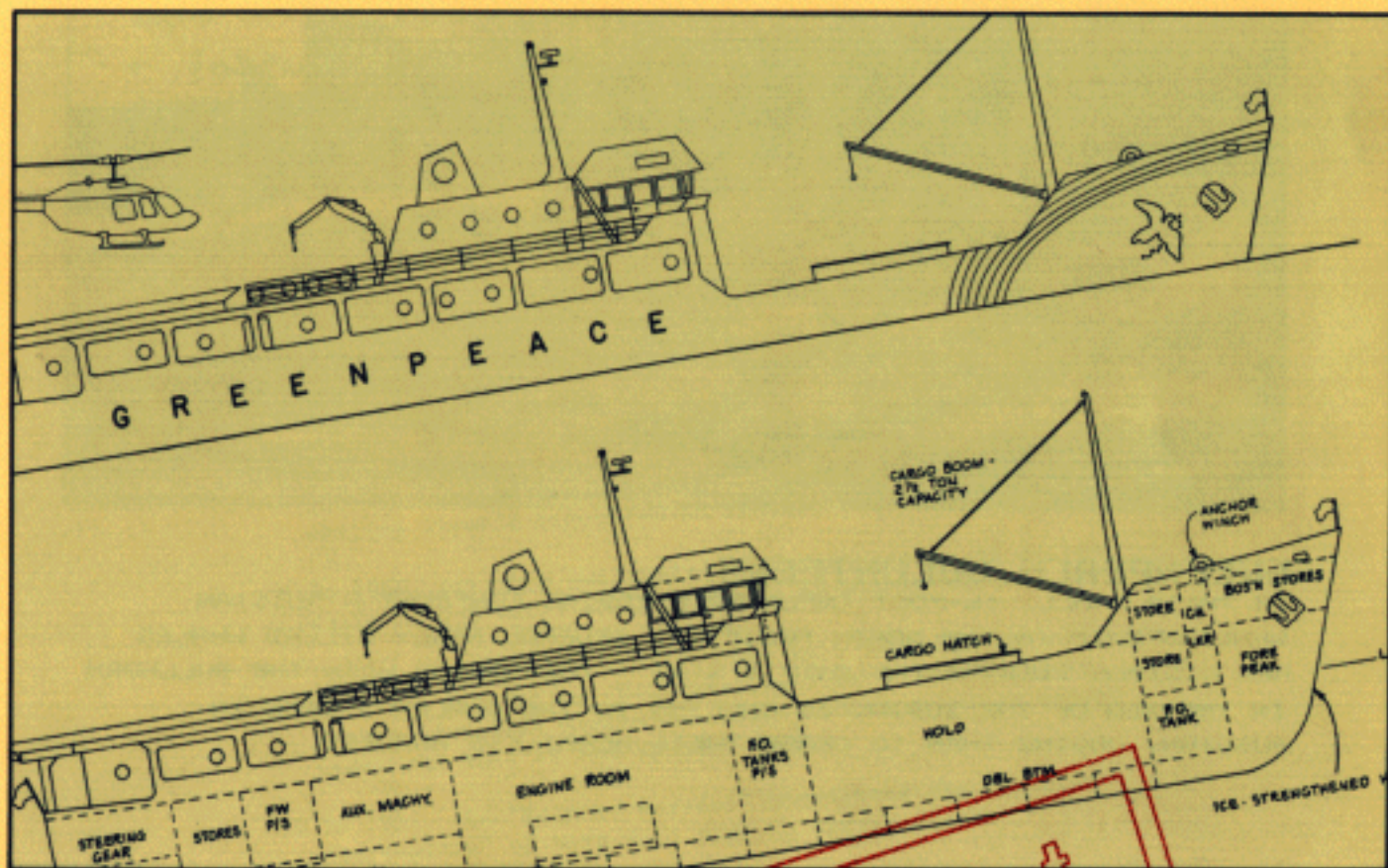

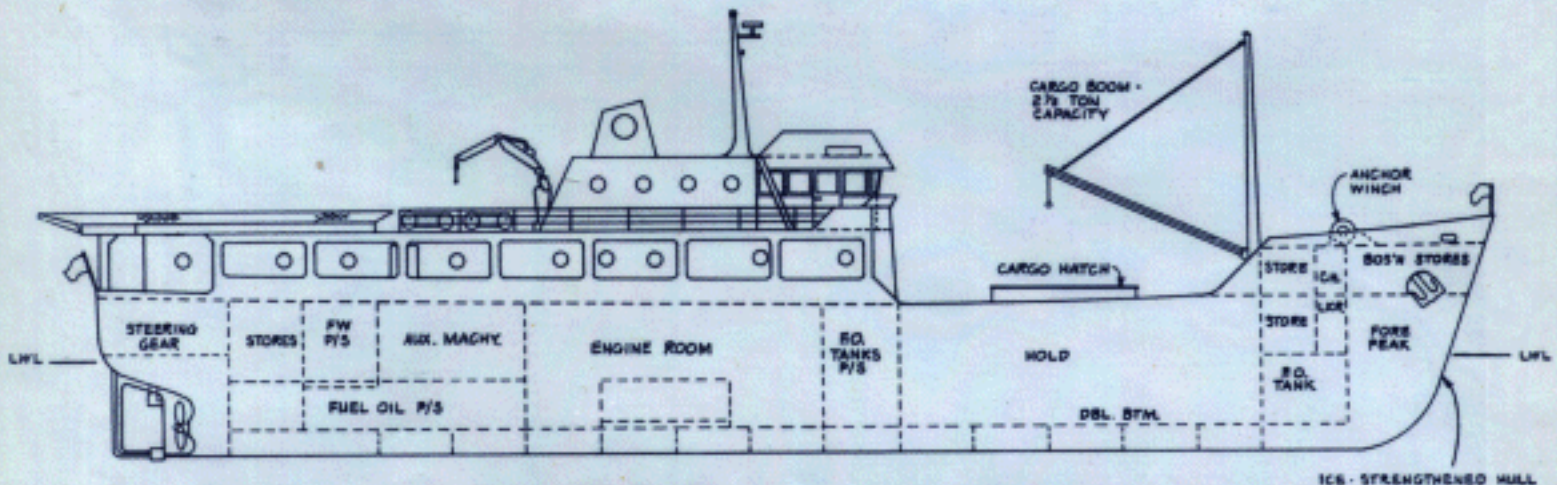
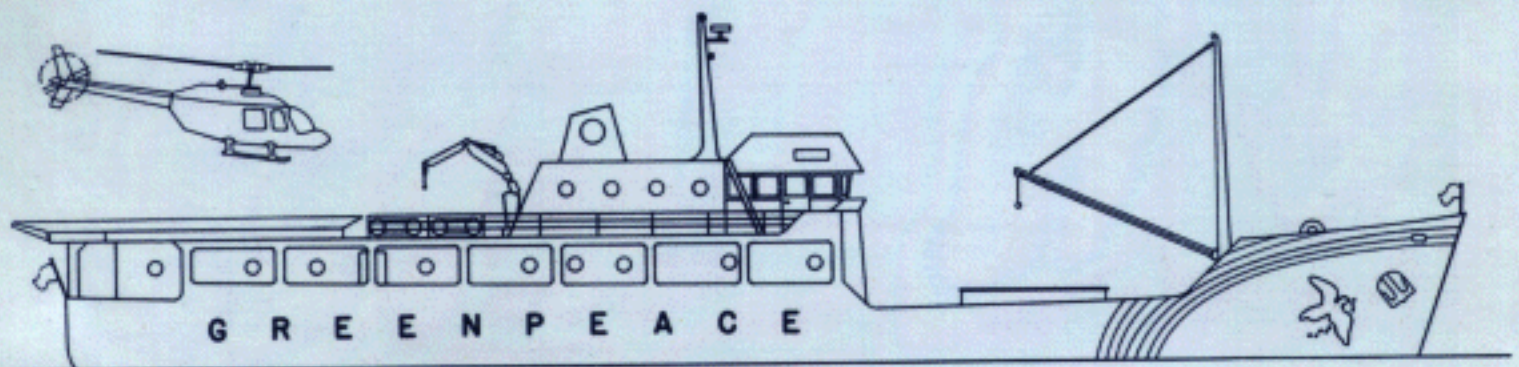

Please return your Greenpeace Acceptance Form today, telling me I can count you in our fight.


